

## **Continuing Care Retirement Communities (CCRCs)**

CCRCs are all-inclusive organizations that provide 3 levels of living, i.e., independent living, assisted living, and skilled nursing care. The facility determines your appropriate level and the charges for each level. Special memory care units are usually available for persons with Alzheimer's and related dementias. There are usually several financial options for residents. Many of the CCRCs have instituted rules that residents must enter while able to function in independent living or with minimal assistance. Common amenities are exercise facilities, indoor pool, on-site and community activities, meal plans, housekeeping, handyman services, transportation, chaplain services, social work and medical services.
